## Vendor Application Guidelines

### Application Submission

- We will only accept Cashiers Check or Money Order. ***NO personal checks or cash will be accepted.***
- Please make your payment payable to: **Makah Tribal Council**

### Conditions

- Enrolled Makah Members will be given first priority.
- Tribal Canoe Families who have completed the registration for their Canoe Family will be given second priority. Canoe Families who have not registered will not be given priority and will be required to pay full price.
- Federally enrolled & recognized First Nations will be given third priority.
- All applications must be completed with signature, and payment.
- By signing this application, applicant agrees to abide by all rules, regulations, and codes established by the Makah Tribal Journey Committee, Makah Tribe and other applicable entities.
- **Hours of operation will only be from 10am to 10pm.**
- **Any attempt to set up your booth prior to Monday, July 19<sup>th</sup>, 2010 will result in forfeiture of all fees paid and your space.**
- Applicants are responsible for providing their own tents, canopies, tables, chairs, skirting, power, water, etc.
- **No selling of: play ink, invisible ink, spray string, “fart spray”, confetti popper, candy cigars/cigarettes, play lighters, “pop it bags”**
- Makah Tribal Journeys Committee has the right to deny any vendor application if deemed unacceptable.
- Food Vendors will only be allowed in the designated Food Court which will be on the west end of the vendor area.
- Food Vendors will only be allowed in the designated Food Court which will be on the west end of the vendor area. Food vendors will be required to supply a certificate of liability insurance.
- Food handler’s permits are also required for individuals handling food.
- The Makah Tribal Canoe Journey Committee will not grant exclusivity of any product.
- Cancellation of Vendor Space after July 1, 2010 will result in forfeiture of all fees paid.

**Vendor Spaces**

- **Space size will be 10x20 with a fee of \$400.00 for the entire week.**
- If you require more than the provided space, you will need to pay an additional fee of \$400.00 for each additional 10x20 space.
- Electricity, running water & lights will not be provided.
- Any attempt to connect to Tribal facilities will result in forfeiture of space & all fees paid.
- Generators are permitted, but not provided.

**Security**

- The Makah Tribe and/or the Makah Tribal Canoe Journey Committee will not be responsible for any lost, stolen or damaged property of the Vendor.
- The Neah Bay Public Safety will be present during the event. If there is a need to contact the NBPD, you may contact them at 360-645-2701.

**Limit of Liability**

- I hear by agree to the terms of the Makah Tribal Canoe Journey Committee Vendor Application.
- **There is absolutely no combination of General/Food Vendor Spaces.**
- I agree to assume all responsibility for my activities as a vendor and agree that I have no claim against the Makah Tribe, for injury, damages to, and/or lost or stolen property. I further agree to hold the Makah Tribe, its officers, employees, Tribal Canoe Journey Volunteers, harmless from all suits, claims, or liabilities of any nature on account of injuries or damages sustained by any person or property resulting in whole or in part from any activities as a Vendor under this application/permit.
- Breaking and/or ignoring any of the rules will result in forfeiture of space and all fees paid.
